These are the Terms & Conditions that apply to The I Love U Guys Foundation (the “producer”) clients hereafter “participant” or “registrant” that attend events produced and presented by The I Love U Guys Foundation.

Your online registration payment will serve as your payment receipt. If your organization will be invoiced, a payment receipt will not be automatically sent, but may be requested.

Early Bird Rate: In order to qualify for any “early bird” rates or discounts, booking and payment must be received before the deadline date listed in the conference marketing material.

Cancellation Policy: We appreciate it when registered remote participants notify us of a cancellation. Pre-paid in-person registrants have the option to send a substitute, or contact us for a refund, prior to the event if they can’t attend.

Should The I Love U Guys Foundation postpone an event or pivot from a live event to a virtual event, registrants have the option to request a refund, or receive a credit to attend The I Love U Guys Foundation program of the registrant’s choice.

The I Love U Guys Foundation may (at its sole discretion) change the format (including, without limitation, from a physical in-person Event to a virtual Event and vice versa), speakers, participants, content, venue location and program or any other aspect of the Event at any time and for any reason, whether or not due to a Force Majeure Event (as defined below), in each case without liability.

Speakers: Views expressed by speakers are their own. The I Love U Guys Foundation shall have no liability for advice given, or views expressed, by any speaker at the conference or in any material provided to participants. The I Love U Guys Foundation may use the speaker’s name and presentation materials for promoting attendance at the conference. Presentations and papers including all associated artwork and illustrations will not be returned unless specifically requested by the author. The papers must be objective and completely free of advertising and commercialism. The I Love U Guys Foundation may audio and/or video record sessions and the recording may be reproduced and sold as part of the overall conference materials. Speakers and delegates consent to the incidental use of their names and likenesses to the extent included in any such audio and/or videotape. Any acknowledgment regarding Copyright or support should be included at the end of the abstract/presentation.

Data Protection: By submitting registration details, registrants agree to allow The I Love U Guys Foundation to contact them regarding the event they registered for.

Websites & Links: The event and associated The I Love U Guys Foundation websites may link to other websites and networking tools provided for the convenience of the users. The contents of these websites are maintained by their owners, for which The I Love U Guys Foundation takes no responsibility.

Insurance: It is the responsibility of the participant to arrange appropriate insurance they may desire in connection with their attendance at the conference. The I Love U Guys Foundation shall not be liable for any loss, liability or damage to personal property.

Participant hereby agrees that they will not provide or permit others to use their login credentials.

Any posts, messages or other information Participant supplies or submits to a Virtual Event platform will be considered non-confidential and Participant hereby consents to and authorizes The I Love U Guys Foundation to use, copy or distribute and disclose any such post, message or information to third parties.

The I Love U Guys Foundation may at anytime refuse access, remove or block any person from the Virtual Event platform who fails to comply with these terms and conditions. Participant agrees to comply with all reasonable instructions issued by The I Love U Guys Foundation to participate in the Virtual Event.

The I Love U Guys Foundation reserves the right to modify or amend these terms and conditions at any time, which changes shall take effect upon notification of Attendee via any medium of communication available.
